Motion passed to approve minutes of June 2019 as submitted.

Treasurer's Report

Kim Sherman presented the June report showing a fund balance as of 5/30/19 of \$15,219 and a total membership of 234.

Following discussion <u>motion passed</u> to sponsor Oregon Minority Lawyers Association (OMLA) at \$150 level, Opportunities for Lawyers in Oregon (OLID) at \$150 level, and when requested Campaign for Equal Justice (CEJ) at \$200 level. These expenses are allocated to the contribution line item in the budget. The committee noted that expenses for Call to the Bar were approved previously, though as a special project line item rather than a contribution line item. The committee also noted that Seniors Advocating Generational Equity (SAGE) had received support in the past.

Following discussion <u>motion passed</u> to reimburse Tonkin Torp for \$300 for Summer Social refreshments (if actual qualified costs were in excess of \$300, Tonkin Torp may make another request); <u>motion passed</u> to reimburse Max Miller \$17.98 for Summer Social costs.

The committee discussed preparation of a 'how to' handbook to assist in transferring responsibilities from the current treasurer (Kim) to the incoming treasurer (Sara).

12:30 Committee Reports

Legislative – June reported that SB 361 had passed both houses and awaits the Governor's signature: this bill is the second in the nation to add sustainability factors to the prudent investor standard for trustees. The committee discussed: adding a Law Improvement article to the SFS website; sending an email blast; adding to SFS Section flyer as accomplishment; considering a CLE program for 2020 on how to use this bill; considering adding to Call to the Bar in 2020 as program addition.

Awards/Partners – Cheyenne reported the committee had not met in June and will contact Alex. The next committee activity is the EcoChallenge starting in October.

Communications – Doug reported that he updated the SFS web page, and that Chris is working on the Green Pro Bono web page addition.

Climate Change and Programs – Sara presented a written summary of the June 26th Climate Change Committee meeting. Committee activities include: legislation study group; green pro bono button; Call to the Bar National Conference; 2019 CLE on Methane Regulations; Legal Road-Mapping CLE for Solutions in "Project Drawdown"; CLE programming ideas. Upcoming events include July 18th Call to the Bar followup cal,l and September 20th event at Tonkin Torp. The committee will next meet September 25th.

Bar Update – Sarra reported that there were no OSB updates.
